A. QUESTIONS FROM BIDDERS:

- Q1: Please Confirm the \$90,000 allowance for Utility Connection and Engineering Charges include the cost of the Domestic Meter & Tap Fee, Irrigation Meter & Tap Fee, Detector Check & Vault, Fire Hydrant + 5' of Pipe, Salvage & Remove Fire Hydrant and Sanitary Sewer impact.
- A1: Yes.
- Q2: Drawing 01.004 shows a price of \$314,518.75 for FF&E. The amount is dated December 2018. Please confirm if we are to use the priced listed on drawing 01.004 in our bid or should we use an actual quote received from an office furniture company with current pricing.
- A2: The 2018 prices listed on sheet 01.004 are provided as a point of reference only. The bidders must include current pricing numbers in their bid proposals.
- Q3: Allowance 2 includes \$13,000 for lease of gravel parking across the street for contractor's use. Please clarify how much parking is included in the allowance and how much parking is the contractor allowed as part of the allowance.
- A3: In lieu of two Greyhound parking spaces as indicated in Allowance Number 2, provide four spaces dedicated to Greyhound. This is a gravel lot and is not striped. Number of spaces available to the contractor will depend on how the contractor lays it out. The gravel lot is located across Forsyth Street from the new station and is partially indicated on sheet A0.200 Phasing Plans.
- Q4: Section 7.7 of the soils report provides potential variables in regards to the building foundation (undercut or aggregate piers). Please provide a clarification to confirm the owner's desire to use undercut or aggregate piers for this project.
- A4: Aggregate piers are to be used as indicated on the structural drawings and specification section 31 12 00- Aggregate Piers.
- Q5: The Proposal Form, Certification and Certification of Restriction of Lobbying, Debarment Certification, Buy America Certification and Certification of Compliance with State of Georgia's Sexual Harassment Prevention included in the project manual are "secured" and can't be printed. Please provide a printable copy of the documents for our use.

A5: NBA contacted the ARC representative who provided the following response:

If they try to print from the point of just viewing the specs, they will encounter problems. It has been set up so that they can only download (instant download) or order prints (from ARC) from the current set only. One can view files under the 'issues' tab, but you can't print from there.
